Agreement for a Hydrant Mounted Meter

To: Whom It May Concern

(Hydrant Meters available M-F 8am – 3pm) after 3pm you can schedule to have them set the next business day.

- You agree to the following terms for the use of a hydrant mounted water meter to be used solely on the Greensboro Water Resources Department water system.
- You agree to pay the requisite meter deposit based upon the required meter size as established by the Greensboro City Council.
- You are responsible for the meter once it is installed on the hydrant. You are responsible for any damage to the meter, fittings and the hydrant. If the meter is lost or stolen, your company is liable for the cost of the meter and the fittings.
- The meter will be read and inspected on a quarterly basis and your company will be **billed a service charge of \$30.00 per month, plus the cost of the water used based on the non-residential rate in effect.** The service charge and the non-residential rate are subject to change and will be based upon the rate in effect each month the meter is used.
- It is the responsibility of the company to return the meter to the Meter Shop when use of the meter is no longer required. **The Meter Shop can be contacted at (336)373-2071 or (336)373-4378**
- After the meter has been removed, and returned to the meter shop the final bill will be determined. The deposit will be applied to the final amount owed. The company will be refunded or invoiced for the difference based on the total amount of the final bill.
