Parks and Recreation Summer Camp 2020 Giveaway Official Rules

TO ENTER: To enter this giveaway, a participant must:

- (i) Attend the February 28, 2020, Summer Camp Fair at Lindley Recreation Center, 2907 Springwood Dr., between 5:30-7 pm.
- (ii) Complete the contest form provided with their contact details to be eligible to win.
- (iii) Limit is one entry per adult.

ELIGIBILITY: This giveaway is open to U.S. residents 18 years of age and older. Proof of age must be furnished upon request. No purchase is required. Employees, contractors, and Greensboro Parks and Recreation and immediate family members of all such persons, are not eligible to participate in this giveaway. Greensboro Parks and Recreation reserves the right, at its sole discretion, to cancel, terminate, suspend, or amend this giveaway at any time for any reason. Greensboro Parks and Recreation further reserves the right to amend these giveaway rules at any time without prior notice, at its sole discretion. Greensboro Parks and Recreation reserves the right to disqualify any participant for any reason, including, but not limited to, violation of these Official Rules or infringement of the rights of a third-party.
