Conversion Burners (automatic firing) Heat Exchangers Warm Air & Cooling Systems

All equipment, apparatus, ductwork, hoods, associated connections, and appliances as part of the heating and cooling system **require** a Final Inspection and a Certificate of Compliance before any new system, portion of the new system, or modified system is put into use.
